The festival grounds will open for cook teams Friday, March 11 at 9am. All contestants must be in place by Saturday, March 12 at 9am.  
All participants and equipment must be removed from the park before Monday, March 14, 2022.

Trophies will be presented for 1st, 2nd, and 3rd Place in all 6 categories listed.

Patrons are asked to cast their vote for "People's Choice" through "tips". Those tips are donated to the South Baldwin Chamber Foundation. The team that collects the most tips, will be awarded the "People's Choice" award. Teams are asked to provide meat (any kind) or BBQ related dish for sampling. In addition to meat some examples include baked beans, mac-n-cheese, and potato salad. Samples will be held from 11am until all samples run out. SBCF will provide each team with a meat voucher to help lessen the cost of meat samples. Voucher to be used only at the Foley Piggly Wiggly.

Teams may enter any and all categories. \*Must enter Ribs, Chicken, and Butt categories to be considered for Grand Champion Award. Alabama BBQ Association and KCBS will only be awarding BBQ Trail points in chicken and ribs.

Contestants shall provide all needed equipment and supplies. Safety at this event is paramount. Any unsafe acts or safety issues identified by the SBCF Representative will be immediately corrected. Failure to follow the directions of the SBCF Representative may cause removal from the grounds. Contestants must adhere to all fire and safety codes. A fire extinguisher shall be near all cooking devices.
